5. Children's Playground

- a) Repairs to the slide equipment still need to be completed on the slope part. Mr. Gibbons advised that he hopes to purchase the boarding required this week 19.06.15, then paint with anti-slip paint, so hopefully repairs can commence weekend or the following week, when Mr. Gibbons and Mr. Platts are available. Mr. Gibbons to liaise with Mr. Platts directly.
- b) Work on the Christmas tree corner still remains outstanding, Mr. Gibbons confirms that Mr. Sweeting can source the metal tubing required, and that he is just waiting on Mr. Sweeting to provide the tubing before work can commence. Mr. Gibbons will go see Mr. Sweeting this week and ask for an update, both on the Tubing and the Defibrillator fitting. Mr. Gibbons advised that when he has the tubing he will contact Mr. Copley and Mr. Platts to arrange dates/times for the work to be carried out.

6. Minster Rail Campaign

Broomfleet parish council were contacted to see if we would like to join the campaign to try and reopen the railway line from Beverley to York. Mr. Gibbons read out the literature sent for all to digest. Miss. Hall suggested that we should wait until the next meeting when we have a complete council to make this decision. All councillors agreed to Miss. Hall suggestion, Clerk is to add to next month agenda.

7. Public Health Bus

This is a service offered to rural parishes, when residents that has to travel into larger towns. The bus comes to the parish and offers health checks for the residents. Mr. Copley said this was a really good idea for those who cannot drive. Miss. Hall suggested that we advertise this service first to see if there is any interest. Mr. Platts, Mr. Copley and Mr. Gibbons suggested that we book the bus and advertise the date/times once confirmed. It was agreed to book the bus and once date is confirmed, advertise in the Village Hall numerous notice boards and the PC notice board. Mr. Copley suggested that we should perhaps request that the bus come on a Tuesday or a Thursday to co-inside with the Post Office.

8. East & North Yorkshire Waterways Partnership – Joint Forum

This forum care for and develop these unique features which meander through our varied landscape. We do this because we value them for the social, economic and environmental benefits they can bring to local communities. Mr. Gibbons read out the relating literature and asked if we are to join the forum or not. All agreed that we would not join the forum.
